**Areas benefited:** Iowa, Wisconsin and the Midwest

**Length of route:** Approximately 102 miles

**Voltage:** 345,000 volts

**End points:** The western end point of the line will be at the Hickory Creek Substation in Dubuque County, Iowa. The eastern end point of the line will be the Cardinal Substation in the town of Middleton, Wisconsin. As part of the project, there also will be a new substation in Montfort, Wisconsin, called the Hill Valley Substation.
